SCHOLARSHIP FUND

CRITERIA:

Should there be no applicants seeking these three priorities, the Scholarship Selection Committee may consider a qualified applicant who desires to seek another profession field of endeavor.
- C. Evidence of a desire to pursue such a program and to continue training for a "two" or "four" year degree.

 - 2. WHAT do you expect college to do for you?
 - 3. WHAT are your plans for the future?
