Instructions to accepting a Federal Direct Stafford Loan

Complete and return the Federal Direct Stafford Loan Cover Sheet to the Financial Aid Office, VAN 105.

The next steps for you to apply for your Federal Direct Stafford Loan is to complete your Entrance Counseling and Master Promissory Note (MPN) at <u>www.studentaid.gov</u>. If you completed the Entrance Counseling and Master Promissory Note for the previous year, you do not need to complete them again.

The online counseling will take approximately 20-30 minutes. When you have completed the Entrance Counseling, you can then complete the MPN.

THE ENTRANCE COUNSELING MUST BE COMPLETED BEFORE COMPLETING THE MASTER PROMISSORY NOTE.

To begin the process:

- 1. Go to www.studentaid.gov
- 2. Hover over the option that says *Loans and Grants*, click on: *Loan Entrance Counseling*
- 3. To the right of where it says "I am an Undergraduate Student" click on: *Log in to Start* and follow the prompts.

Our school name is *Ulster County Community College* When you are done with the entrance counseling, move on to steps 4-5.

- 4. Hover over the option that says *Loans and Grants*, click on: *Master Promissory Note (MPN)*
- 5. To the right of where it says "I am an Undergraduate Student" click on: *Log in to Start* and follow the prompts.

After completing all the above steps, the school will receive notification that you have completed your Entrance Counseling and your Master Promissory Note.
