**Math for Wastewater Operators** As an operator, you will use math on a daily basis. This course serves as a refresher to those who have not used basic math, algebra, and word problems for a while. We will apply the wastewater formula sheet to the types of problems you will meet on the job. This course is a prerequisite for the Operations and Laboratory classes.

**Basic Wastewater Laboratory** The course is designed to enable the wastewater operator to perform those laboratory procedures which are necessary to determine control strategies for the efficient operation of a wastewater treatment plant. Prerequisite: Math for Wastewater Operators.

**Basic Wastewater Operations Lecture** The student will study the characteristics of each individual process within the plant and will learn how those processes are joined to achieve the desired results. Prerequisite: Math for Wastewater Operators.

**Activated Sludge Course** Operational control strategies for an activated sludge plant will be presented and discussed and the student will be able to apply laboratory data to the proper control of the activated sludge process. Safety and regulatory recordkeeping are emphasized.
