She was a mixed media artist working in fibers, metals, gemstones, and beads. Kumihimo, the Japanese method of cord making, along with traditional jewelry making, were the techniques she used to create one-of-a-kind necklaces. In addition to that, she created works of art in felt, for which she received awards. She utilized natural dyes from an early age, growing, harvesting, and gathering from nature and her garden. Susan's creations have been exhibited both nationally and internationally. Susan was a gracious hostess, welcoming friends, family, and the community into her home.

ALEJANDRO DURAN SANCHEZ '19

Alejandro Duran Sanchez was born in Mexico and came to the United States at just three years old. After a short time in California, his family settled in Kingston, New York — a city that would become the backdrop for most of his life. As a young child, Alejandro entered the Head Start program without knowing a word of English. Thanks to the help of dedicated teachers and his own determination, he quickly picked up the language and never looked back. From Sophie Finn Elementary to J. Watson Bailey, a brief three-year stint in Indiana, and then returning to graduate from Kingston High School, Alejandro's early years were marked by constant change, resilience, and growth.

Although academics didn't come first for him in high school — athletics often took the spotlight — Alejandro always knew he had more to give. After being rejected from several colleges, he chose to attend SUNY Ulster, despite the doubts of many around him. While some looked down on community college, Alejandro saw opportunity. He poured himself into his studies, earned high honors, joined student government, worked closely with the admissions and marketing departments, and built lasting connections. It wasn't long before the very colleges that once turned him away — including Siena and University at Albany — were now offering him acceptance letters and scholarships.

Alejandro transferred to University at Albany, where he majored in marketing and graduated with his bachelor's degree. Throughout college, he worked over 40-60 hours a week between ShopRite and Starbucks, grinding to make ends meet while keeping his goals in focus. Just four months after graduating, Alejandro made a bold decision: to launch his own business. With money saved up and a starter camera, he founded Volna Unalign, a digital marketing and media agency that is now going on five years strong. What started as a solo hustle is now a thriving business with clients across the Hudson Valley — and soon, across the country — producing high-quality content, videos, and marketing strategies for businesses big and small.

None of it, Alejandro says, would have happened without SUNY Ulster. That school gave him a second chance — a space to grow, to lead, and to believe in himself. Their motto, "Start here, go far," isn't just a slogan to him. It's his story. And he wears that journey with pride, proving that with grit, heart, and vision, you can come from anywhere and create something extraordinary.
